

HOW TO APPLY FOR A VISA TO THE PEOPLE'S REPUBLIC OF CHINA

All participants for whom Chinese visas are required should follow the procedures and present the required documents as listed below. It is recommended that the applications be made as early as possible.

Procedures:

1. Fill out the visa application form posted on the web site of 60th Session on the ESCAP homepage at <http://www.unescap.org/60/index.asp>
2. Prepare the required documents.
3. Submit the application with all required documents as early as possible.

Required documents:

1. Passport with validity of at least six months and sufficient blank pages.
2. One completed and duly signed application form. If the application form is not complete or the contents are inaccurate, the visa approval will be delayed or denied.
3. One passport photograph 2x2 inches in size, either black and white or colour.
4. A copy of invitation letter for the ESCAP 60th Commission Session.
5. A document certifying that the applicant is representing his/her Government/Organization in the 60th Commission Session.

Recommended channels of visa application for participants from countries without Chinese Embassy or Consulate:

The visa application can be made through one of the following channels:

1. Participants may personally carry the required documents to the Chinese diplomatic or consular missions in a third country /region en route to entering China to obtain their visas. For participants with time constraint, an advanced application may be made by sending copies of required documents to the Chinese diplomatic or consular mission, and the visas will be picked up later in person. Participants are strongly encouraged to make pick-up appointments with the Chinese diplomatic or consular mission.
2. Participants may send all the required documents to ESCAP Secretariat in Bangkok. ESCAP will coordinate the application process with the Chinese Embassy in Bangkok and return the passports with visas to the applicants. **The documents should only be sent by express mail/courier services.** The latest date that ESCAP will accept the visa applications through this channel is **15 March 2004**.
3. A visa application can be made at the nearest Chinese Embassy/Consulate through the respective Government's diplomatic mission or representative.

三、未经批准，不得在中国境内任职或就业。

NOTES

- 1 The application for a visa may be declined if the applicant fails to provide with true and complete information in the form. The applicant shall bear all the consequences arising therefrom.
- 2 The person holding X, Z, D, or J-1 visa shall go through residential formalities in the local public security department within thirty days since the date of entry.
- 3 Employment in the territory of China is prohibited without approval.
