Loan support:

- The government provided a PGK 600 million credit line to support MSMEs¹⁸, state-owned enterprises and individuals.
- The government lowered the policy interest rate by 200 basis points from 5 to 3 per cent to support reductions of commercial banks' loan interest rates.¹⁹
- Support for businesses includes K200 million in guarantees for loans to SMEs.²⁰

Deferral of loan repayment:

• MSMEs, state-owned enterprises and individuals can defer loan repayments for three months.

Employment support:

• The government allocated PGK 500 million from superannuation savings to subsidize employees of MSMEs and state-owned enterprises.

Other policy measures

International cooperation:

- April 14, 2020: US\$20 million World Bank funding part of Global Covid-19 response package. Provides new laboratory, equipment, medical supplies an funding for PNG-Australia ravel of lab samples for quality assurance²¹
- May 20, 2020: USD1 million UN Covid-19 Response and Recovery fund ²²
- May 26, 2020: USAID allocated US\$9.9 million towards covid-19 efforts in Pacific Island regions of FSM, Fiji, Nauru, Kiribati, Palau, Papua New Guinea, Marshall Islands, Samoa, Solomon Islands, Tonga, Tuvalu and Vanuatu. (USD3.55 million allocated to Papua New Guinea²³)
- June 9, 2020: the IMF Executive Board allocated US\$363.6 million in emergency financing under the Rapid Credit Facility (RCF) to help PNG address urgent balance of payments needs created by COVID-19²⁴.
- July 30, 2020: The Asian Development Bank (ADB) announced more than \$13 million in grants to help Pacific countries finance responses to the COVID-19 pandemic, including \$3 million for Papua New Guinea.²⁵
- August 10, 2020: The ADB approved a \$31 million loan to expand improve the road network in Papua New Guinea.²⁶
- November 26, 2020: The ADB issued \$150 million loan to provide all

- PNG citizens with affordable, accessible, high-quality health services.²⁷
- November 26, 2020: \$250 Million Loan approved by the ADB.²⁸
- December 9, 2020: A \$93.75 million loan has been agreed by the ADB and global agribusiness company Olam International Limited (Olam) to support the livelihoods of smallholder farmers in Viet Nam, Indonesia, and Papua New Guinea by helping them cope with supply chain disruptions caused by COVID-19 pandemic. ²⁹
- ADB: December 2 2020: USD0.03 million technical assistance under Promoting Transformative Gender Equality Agenda in Asia and the Pacific; December 8 2020, USD250 million COVID-19 Rapid Response Program; USD50 million Health Services Sector Development Program.³⁰17 December 2020: USD0.35 million technical assistance under "Supporting MSMEs in the Pacific from the Effects of COVID-19 Pandemic".³¹
- December 23, 2020, Paris Club granted suspension of debt service due from 1st January to 30th June 2021.³²
