Annotation

The document, containing the summary of the latest results of the United Nations Global Survey on Digital and Sustainable Trade Facilitation for Asia and the Pacific, will serve as general background information for this agenda item. Led by the Economic and Social Commission for Asia and the Pacific (ESCAP), the United Nations Global Survey on Digital and Sustainable Trade Facilitation is a biennial survey jointly conducted by the five regional commissions and several global and regional partners. The survey covers 53 measures, including digital trade facilitation measures for both paperless and cross-border paperless trade. Survey data is available at https://untfsurvey.org/. Available preliminary results of the 2021 Global Survey will be presented and discussed, including on paperless trade measures taken as a result of the coronavirus disease pandemic.
