Masterplan on Transport Connectivity by the 5th Summit is a milestone in this regard.

We now hope that the Member States will work on implementing the components of the Master Plan, which will ensure the achievement of our aspiration for a truly connected Bay of Bengal Region.

The COVID-19 pandemic, has highlighted the need to develop uninterrupted supply chain for food, medicines and other basic essential commodities.

With the disruption in global supply chains, the need and opportunity to create intra-regional trade has emerged. Therefore, trade facilitation measures like simplification of customs procedures, introduction of electronic tracking system and acceptance of electronic copies need to be worked on.

The ongoing pandemic has also underscored the need for renewed attention to public health. Member states could collaborate in research, capacity building and use of technology in health, in order to collectively combat future pandemics that may occur.

Collaboration and cooperation in climate change and disaster management is another key area for BIMSTEC since all member states are vulnerable to natural disasters whether it is in the Himalayan region or the coastal areas. Therefore, it is important to develop regional adaptation and mitigation programs to address our region's vulnerability to natural disasters.

As BIMSTEC enters its 25<sup>th</sup> year since its establishment, we hope to take the opportunities provided by the potentials that exist in our region to move collectively towards achieving our goals and objectives with which the organization was founded.
