Seventh Asian and Pacific Population Conference Side Event

"Scaling up humanitarian financing for SHRH/ FP in emergencies in Asia & Pacific"

Background:

In recent decades, international and national initiatives have improved the availability and accessibility of Sexual and Reproductive Health and Rights (SRHRs) among conflict-affected and disaster-affected population groups. As part of the Sendai Framework for Disaster Risk Reduction 2015–2030, the availability of SRHR is emphasized as a key component of strengthening the resilience of individuals and communities. Women's empowerment and gender equality in humanitarian interventions were among the priority issues for the sector at the first World Humanitarian Summit in May 2016, with a total of 70 commitments. Although SRHR services have progressed significantly in humanitarian settings, they remain insufficient. To prevent SGBV and respond to the needs of survivors of SGBV, UNFPA estimates that 35 million women, girls and young people needed lifesaving SRHR services and interventions in 2019. Health services are often difficult to access due to socioeconomic and cultural barriers, gender inequality, and a lack of information about available services. As a result of the humanitarian crisis, these challenges are sometimes exacerbated.

Despite some increases in financial support for SRHR in emergencies, funding is still inadequate to meet the needs of the growing number of crisis-affected communities and is rarely prioritized. The budget for SRH services in humanitarian crises falls a long way short of what is needed to save lives, and increased investment, prior to and during an emergency, can effectively mitigate the impact of future crises. Effective emergency response strategies require capacity development, multistakeholder coordination, improved availability of resources — including supplies — and most importantly, funding.

This panel discussion fits neatly during the Seventh Asian and Pacific Population Conference as we review the implementation of the Program of Action of the International Conference on Population and Development during the fifty-seventh session of the Commission on Population and Development while advancing the full implementation of the 2030 Agenda for Sustainable Development

Objectives:

- Have an open dialogue with key partners on addressing funding gaps.
- Sharing best practices in scaling up investment in SRHR/ FP in Humanitarian
- The important role of government and development partners in Humanitarian and Development Nexus for Health and Sexual and Reproductive Health

Expected Outcome:

The expected outcome is greater awareness of the importance of scaling up the quantity and quality of humanitarian financing for Sexual and Reproductive Health in emergencies and how critical it is for the achievement of Health and Wellbeing for all, gender equality and the broader realization of the Sustainable Development Goals. The cross-sectoral dialogue presents both a challenge and an opportunity for SRHR/FP champions to engage and contribute different perspectives, and pathways to investing in SRHR/FP in emergencies.
