Description of event:

The side event brings the issues and voices of grassroots migrants and refugees in Asia Pacific as they share their current situation post-pandemic. Migrants and refugees are part of the region's population regardless of their number, status and situation. Yet their rights and freedoms have been severely limited, as have their access to quality services, justice and livelihood opportunities. Many people on the move remain undocumented and are easy targets of exploitation, racism and discrimination.

With international migration identified as one of the 11 priority actions in the International Conference on Population and Development, it is only important for migrants and refugees to speak up on matters that impact them as part of the continuing advocacy for migrants and refugees' meaningful participation in advocacy spaces such as the 7th Asia Pacific Population Conference. Specifically, it is important that undocumented people be included in resource planning.

Objectives:

- To provide space for migrants and refugees to articulate and highlight existing and emerging concerns confronting them with a focus on particularly vulnerable migrants and refugees;
- 2. To showcase good and emerging practices of migrants and refugee-led organisations and initiatives:
- 3. To put forward policy recommendations in relation to issues and concerns raised; and
- 4. To submit a statement reflecting issues and recommendations to governments and relevant UN agencies.
