Hybrid meeting

The Second Ministerial Conference on Civil Registration and Vital Statistics will be held from 16 to 19 November 2021 in a hybrid modality: limited in-person at the United Nations Conference Centre in Bangkok and online through the KUDO videoconferencing platform. The Conference is divided into two segments: Senior Officials' Segment and Ministerial Segment.

Given the technical limitations of conducting the Conference through a virtual platform and in view of the mandates and operational requirements of the Conference, priority will be given to the **members, associate members and permanent observers of the Commission** to deliberate on procedural matters.

Limited opportunities to deliberate on procedural matters will be available for observer organizations, intergovernmental organizations, other entities and non-governmental organizations.

All participants who wish to observe the proceedings may do so via broadcast on the Conference website. Details of the broadcast will be made available on the Conference website <https://getinthepicture.org/crvs-decade/second-ministerial-conference> in due course.

Letter of credentials, online registration and speakers list

As advised in the invitation letter of 23 June 2021, each delegation is required to submit a **letter of credentials**, duly signed by the appropriate authority of the respective Government and development partners, at the latest by 31 October. In addition to submitting a letter of credentials for the delegation, each delegate in the delegation is required to register online as soon as possible, but no later than 31 October at <https://meetings.unescap.org/>. Each delegation is also requested to complete the speakers list request form to identify which members of the delegation will have a speaking role during the session. Due to the limited number of accounts to attend the session virtually through the KUDO platform, members and associate members of the Commission, as well as co-organizers can nominate up to four speakers. Permanent observers of the Commission, observer organizations, intergovernmental organizations, other entities and non- governmental organizations can nominate one speaker each. Delegations are requested to complete the speakers list request form and submit it to escap-crvs@un.org with copy to nitiprapathananun@un.org as soon as possible before 5 November 2021.

Due to the uncertainties related to the current COVID-19 pandemic and the need for physical distancing, more information will be provided to the delegates on the access to the conference room in the United Nations Conference Centre at the beginning of November. Furthermore, as the session will be conducted virtually through the KUDO platform, delegates who have a speaking role and wish to be present in the conference room need to be on the delegation list, registered and nominated as a speaker.

Country Interventions and Statements

Delegations wishing to deliver country statements are requested to coordinate among themselves and ***complete only one KUDO speakers request form***, identify which members of the delegations will have a speaking role during each session and submit it to escap-crvs@un.org with copy to nitiprapathananun@un.org, as soon as possible or before Friday 5 November 2021.

Delegates are strongly encouraged to deliver their statements live on KUDO. However, pre-recorded statements will also be possible. For delegates wishing to submit a video message, please refer to the video submission requirements, complete Part III of the Speaker Request Form, and return it to escap-crvs@un.org with copy to nitiprapathananun@un.org as soon as possible and no later than **5 November 2021**. Please note the number of four speakers per country does not include delegates delivering pre-recorded statements. Videos may be transferred via Google Drive, WeTransfer or similar file transfer links to escap-crvs@un.org with copy to nitiprapathananun@un.org and should be submitted as soon as possible and no later than **10 November 2021**.

Upon receiving the completed speaker request form, the secretariat will send a link to the KUDO session to delegates whose names are identified on the form. Please note that the KUDO



link is not transferable.

In view of time constraints, **country statements will be limited to three (3) minutes**. Prepared texts of longer statements may be circulated and will be posted on the Conference website unless requested otherwise.

Delegations are also encouraged to provide statements in advance to the secretariat in electronic form at escap-crvs@un.org with copy to rattanakittiaporn@un.org. Statements will be used to facilitate and draft the report of the Conference. Statements will be posted to the Conference website after delivery, unless requested otherwise.

A guide to using the KUDO videoconferencing platform will be shared in due course with members of each delegation assigned to speak during the session. KUDO users will also be invited to a test-run 30 minutes prior to the sessions to familiarize themselves with KUDO, test the connection and ensure smooth online participation. All KUDO users are strongly encouraged to join the test-run, especially those who will join the KUDO Platform from a meeting room, so they can see if the meeting room conference/AV system is adequately linked to KUDO.

Documents and Interpretation

Pre-session documents are available in the four official languages of the Commission (Chinese, English, French and Russian) and will be posted on the Conference website at <https://getinthepicture.org/crvs-decade/second-ministerial-conference>.

Given the technical limitations of conducting the Conference in a virtual manner and in view of the mandates and operational requirements of the Conference, the report of the Committee on the Conference will contain only three sections: organizational matters, decisions taken, and reference to Chair's summary. A Chair's Summary will be prepared to record the proceedings of the Conference and will be annexed to the report after the conclusion of the Conference.

The report of the meeting will be available in all ESCAP languages on the meeting website by 12:00 noon Bangkok time of 19 November 2021 for consideration by the delegations on the final day of the meeting.

The KUDO platform provides live simultaneous interpretation in the four official languages of ESCAP. Details on how to choose an interpretation channel will be provided in the KUDO participation guide distributed to confirmed participants.

Sign-language interpretation will also be available simultaneously throughout the session.

Declaration and Decision

The Conference will consider for adoption the Ministerial Declaration "Building a more resilient future with inclusive civil registration and vital statistics". The secretariat has shared with members of the Commission a revised draft Ministerial Declaration, which takes into account the comments received during a written consultation. The process for the negotiation of the

Ministerial Declaration will be continued through online consultations and is expected to be concluded prior to the Conference through use of the silence procedure.

Members of the Commission have been invited to participate in these online consultations. The first meeting took place on 11 October 2021 between 12:00 and 14:00 hours, Bangkok time (GMT+7). A second meeting will be held online on 25 October 2021. Agenda item 2 of the provisional agenda will start with a presentation on the summary of findings of the documents under this agenda item. Guest speakers will be invited to provide remarks on progress towards specific goals and implementation steps of the Regional Action Framework. Following these remarks, the floor will be opened for statements from countries, development partners and the civil society.

Under agenda item 2, it is anticipated the Conference will renew regional commitment to the shared vision of the Decade and provide guidance on how to accelerate progress towards this vision. Delegations may thus wish to focus their statements on the issues for recommendations from the supporting documents, share experiences and progress towards the goals and targets of the Regional Action Framework and provide guidance on how to overcome the remaining challenges. Agenda item 3 of the provisional agenda will start with a presentation on the summary of findings of the documents under this agenda item. Guest speakers will be invited to provide remarks on strengthening productive collaboration between civil registration authorities and health sector stakeholders. Remarks will also be provided on the importance of a well-functioning civil registration and vital statistics system to generate a continuous stream of data on births and deaths to support decision-making at national and subnational levels.

Following these remarks, the floor will be opened for statements from countries, development partners and the civil society.

Under agenda item 3, the Conference may wish to provide further guidance and advice on how to strengthen productive collaboration between civil registration authorities and health sector stakeholders and how to ensure better data on all-cause mortality and causes of death. Delegations may thus wish to focus their statements on the issues for recommendations from the supporting documents, share experiences on strengthening collaboration between civil registration authorities and the health sector, and improving data on all-cause mortality and causes of death. Furthermore, delegations may also wish to comment on the role of verbal autopsy for deaths taking place in the community and without the attention of a medical practitioner and to share experiences of its integration into civil registration and vital statistics systems.

Warm-up Session: Civil registration and vital statistics as an accelerator for the Sustainable Development Goals (12:45-13:30, GMT+7)

Before opening Agenda item 4 of the provisional agenda, a warm-up session dedicated to the topic of Agenda item 4 will be organized. It will focus on the participation of children and youth in implementing functioning CRVS systems. The session will feature the voices of children and youth, who will share experiences of the challenges faced by children, youth and their families in birth, marriage and death registration and discuss the importance of including children and youth in consultations on the issues of civil registration. The session will also showcase the multisectoral collaboration in the Philippines to improve birth registration among indigenous Sama Bajau who live in remote areas, with a representative from the Sama Bajau community providing their insights. children and youth representatives on their participation in consultations on issues of birth, marriage, and death registration/certification. In addition, representatives from civil society organizations and countries will provide remarks on where greater progress is needed to reach hard-to-reach and marginalized population groups and share experiences of good practices to achieve universal registration that leaves no one behind. Following these remarks, the floor will be opened for statements from countries, development partners and the civil society.

Under agenda item 4, it is anticipated the Conference will provide remarks on the linkages between sustainable development and well-functioning civil registration and vital statistics systems, in particular to ensure that everyone can realize their right to a legal identity and is included in official statistics. The Conference may further wish to provide guidance on how to accelerate inequality assessments for civil registration and vital statistics systems in Asia and the Pacific. Delegations may thus wish to focus their statements on the issues for recommendations from the supporting document, share experiences and discuss areas where more efforts are needed to address inequalities during the second half of the Asia and Pacific Civil Registration and Vital Statistics Decade (2015-2024).

Under agenda item 5, it is anticipated the Conference will provide guidance on how to ensure that all members and associate members achieve the goal of producing and disseminating accurate, complete and timely vital statistics including on causes of death, based on registration records, as a means to support improved understanding of subnational differentials in fertility, mortality, and nuptiality outcomes. Delegations may thus wish to focus their statements on the issues for recommendations from the supporting document, share experiences and opportunities to enhance the production of and dissemination of vital statistics on births, deaths, causes of deaths, marriage, divorce, maternal deaths, foetal deaths and induced abortions.
