ROADMAP FOR IMPLEMENTATION OF THE SPECA TRADE FACILITATION STRATEGY

The SPECA countries should concentrate on the following priority activities:

- 1. Review implementation and identify priority measures for trade facilitation implementation in each country; develop regional cooperation framework to support their implementation.
- **2.** Strengthen the sustainable functioning of the National Trade Facilitation Committees of the countries and the network of cooperation among them. Organize regional and bilateral meetings and training events. This regional network can help coordinate donor support.
- **3.** Strengthen cross-border cooperation on consultations between public and private stakeholders, e.g., on new or revised national legislation.
- **4.** Cooperate on the implementation of international standards for trade facilitation with the assistance of international organizations and development partners, involving the NTFCs.
- **5.** Develop more detailed national trade facilitation road maps/action plans in each country, in compliance with the country's other development plans, and reflecting the goals of this regional cooperation strategy.
- **6.** Exchange best-practice experiences in: electronic payments; appeal systems; periodic review of the use of international standards, fees and taxes, risk management, exchange of information among Single Window systems and, in the Customs area, in implementing prearrival processing, separation of the release of goods from the final determination of duties, post clearance audit, priority processing of perishable goods, temporary admission of goods and inward and outward processing.
- **7.** Take steps towards harmonizing risk management systems in the region and establishing risk data exchange between the countries.
- **8.** Cooperate among the countries on reviewing formalities, documentary requirements and procedures, with a view to simplifying them; encouraging the harmonization of procedures among the countries.

- **9.** Share information, organize joint training activities and cooperation mechanisms.
- **10.** Cooperate, if possible, on establishing a SPECA trade facilitation web page with relevant information.
- 11. Establish trade facilitation enquiry points in each country (using the SPECA guide on trade facilitation enquiry points), and foster exchange of information among these enquiry points among the countries.
- **12.** Implement Authorized Economic Operator (AEO) schemes; and explore possibilities to harmonize criteria for nominating AEOs, in order to allow for developing mutual recognition of AEOs, as well as exchange of information on the status of separate companies as AEO.
- **13.** Harmonize border-crossing procedures among the countries.
- **14.** Enhance internal and external border agency cooperation through putting together mechanisms of internal coordinated management of trade control agencies active at the border and establishing bilateral cross-border mechanisms (e.g., regular meetings or joint commissions) to coordinate border controls at each border-crossing or related border-crossing points.
- **15.** Develop a regional set of testing laboratories, which would allow for using laboratories in other countries for testing and mutual recognition of the results.
- **16.** Enhance free transit in the region, where fees and charges are commensurate with services rendered; reinforce the implementation of the TIR Convention; establish separate infrastructure for goods in transit.
- **17.** When national transit coordinators are nominated, establish a collaboration mechanism of transit coordinators in the region.
- **18.** Use internationally standardized terminology and trade data definitions.
- **19.** Strengthen cross-border cooperation on balancing trade facilitation with compliance, using modern tools and mechanisms to fight against Customs and other regulatory agency offences and smuggling, as part of improving the governance of international trade.
- **20.** Accelerate the establishment of Single Window and/or Port Community Systems, and ensure interoperability in the region, using international standards.
- **21.** Step up work on the digitalization of trade and multimodal transport data and document exchange using the UN/CEFACT semantic standards, notably the Multimodal Transport Reference Data Model.
- **22.** Share experiences among the countries on implementing trade facilitation measures included in the WTO Trade Facilitation Agreement and the WCO Revised Kyoto Convention.
- **23.** Enable regional and bilateral exchange of Customs information among the countries, notably within a Green Corridor approach, and develop projects on mutual recognition of Customs control results.

24. Participate in the implementation of the Framework Agreement on Facilitation of Cross-Border Paperless Trade in Asia and the Pacific, and in the development of bilateral and multilateral agreements for enabling cross-border mutual recognition of trade data and documents in electronic form.

- **25.** Conduct Time Release Studies (TRS) and Business Process Analyses (BPA) of trade procedures along relevant SPECA corridors, and publish the results.
- **26.** Build trade and transport facilitation monitoring mechanisms (Recommendation 42: www.unece.org/fileadmin/DAM/trade/Publications/ECE_TRADE_437E_Rec42.pdf).
