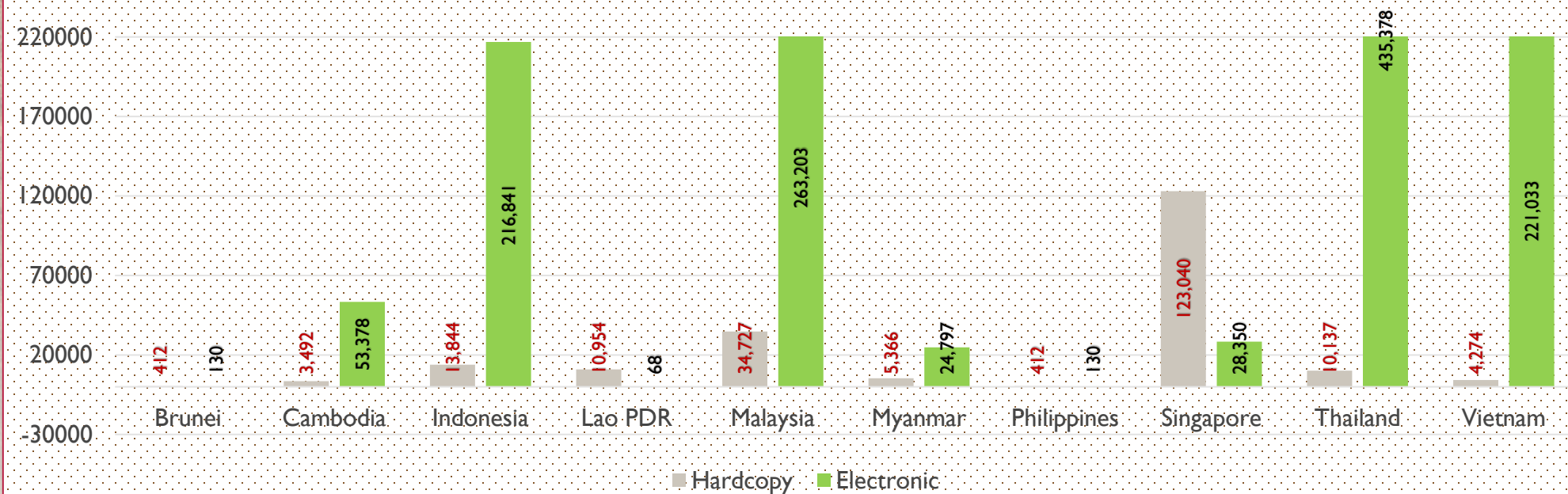

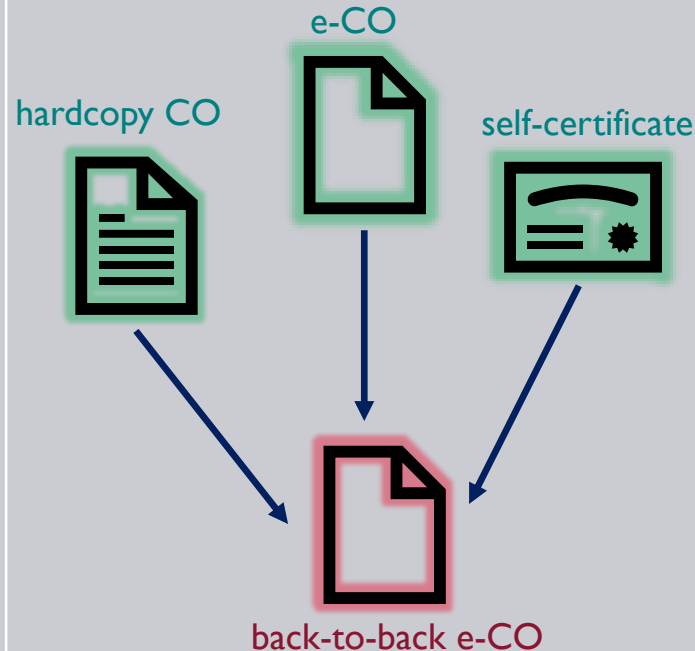

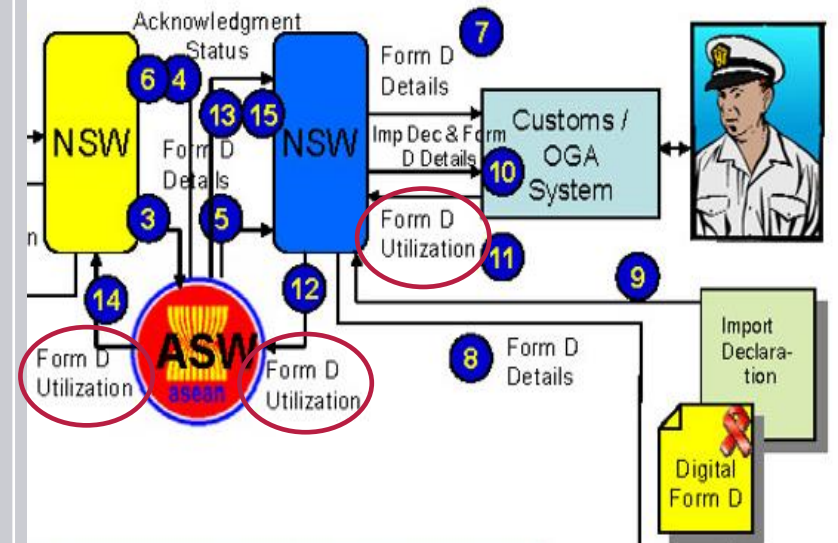

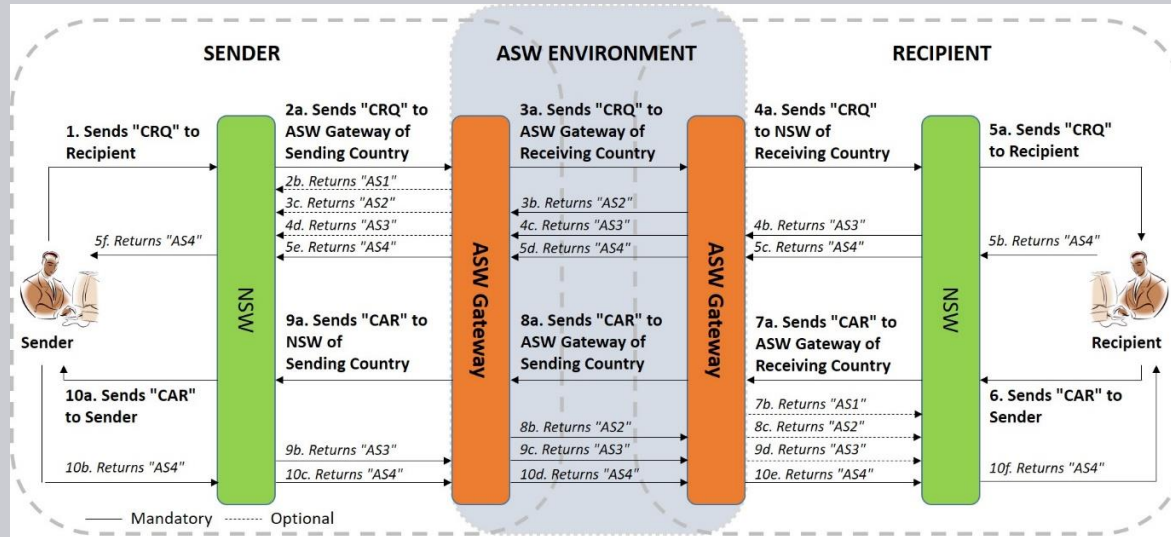
Additional process for Utilization status of ATIGA e-Form D



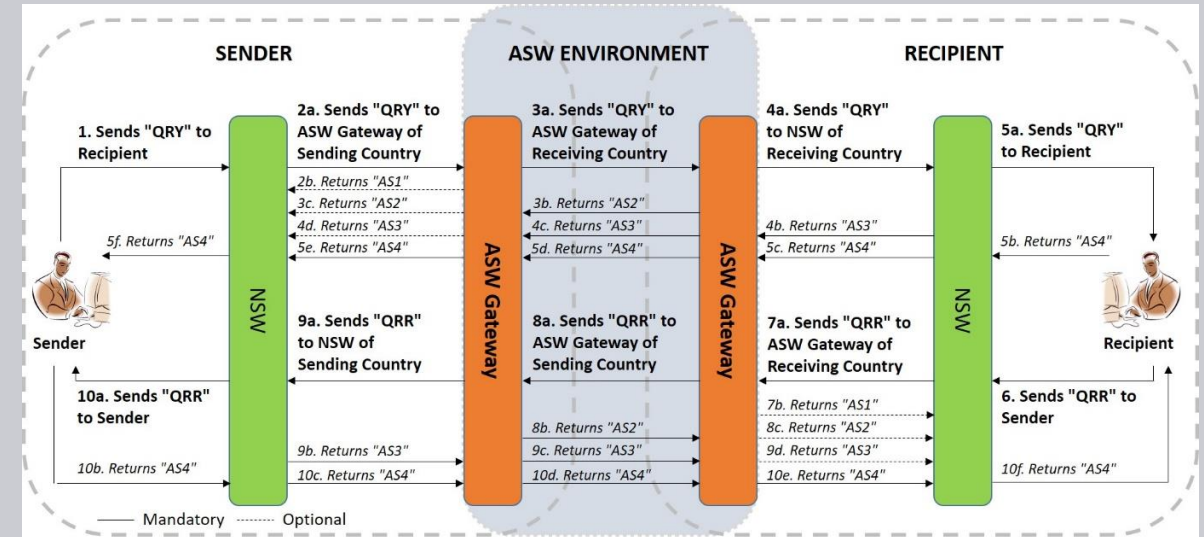
THE NEXT STEPS OF FULL ELECTRONIC PROCESS

THE COOPERATION WITH CHINA



- China comes up with technical specifications for connecting with the China Single Window
- AMS shares the preferred solutions to connect with China
- China proposes the possible cooperation on the establishment of joint working group and the legal framework
- China also prefers to exchange the Inspection and Quarantine Certificates
- ASEAN plans to amend the OCP with China enabling the e-CO by 2022





THE COOPERATION WITH JAPAN



- Japan shares the solutions to connect the Japan's system with AMS, i.e. one AMS NSW as a bridge, connecting point-to-point with NSW of each AMS.
- AMS needs Japan to consider connecting point-to-point with ASW Gateway
- Japan will be able to connect with AMS via more than 1 solution
- The Rules of Origin working body will discuss and complete IR/OCP to enable the e-CO
- The discussion on data format of e-CO will be conducted soon





THE COOPERATION WITH ROK



- Republic of Korea (ROK) is conducting the project proposal for the Feasibility Study on Establishment of ASEAN-ROK Regional CO Exchange Platform expected to be delivered by Q2 of 2023.
- AMS requests ROK to convey ASEAN's message to her administrations on the possibility of initiating technical and legal discussions
- Thailand seeks the interest from ROK for conducting the data harmonization of the e-CO (Form AK) with AMS





MORE COOPERATION WITH USA



- USA expresses the interest to exchange e-CO through the General System of Preferences
- USA is ready to launch discussions for the implementation of the exchange of e-Phyto Certificate via ACE
- USA(US-CBP) proposes initiative to link the ASW with ACE to allow the exchange of the export declaration data
- It is needed 2 to 4 years timeline to implement a Pilot between AMS and the US-CBP to bring about the tangible benefits for the traders

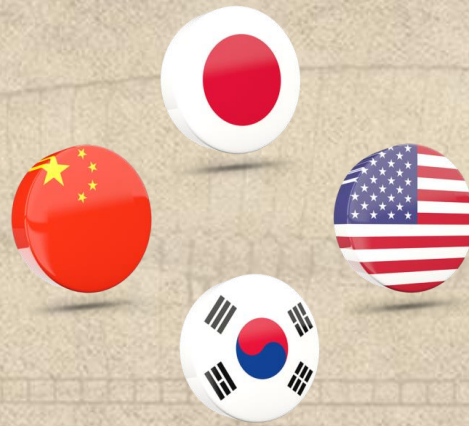


CHALLENGES



- The technical issues are still occurred
- The gaps in AMS readiness make the traders non-fully utilize e-CO
- The ASW gateway is deemed to be upgraded soon
- The platform for the exchange with DPS is pending
- The legal instruments are also required for enabling the approach of DPs
