Review of the progress and remaining challenges in implementation of the Beijing Declaration and Platform for Action in Asia and the Pacific (E/ESCAP/GEWE/1)

Annotation

Under this agenda item, the Conference will review the progress made in the past 20 years, as well as remaining challenges, in the Asia-Pacific region in achieving gender equality and women's empowerment.

As a basis for its deliberations, the Conference will consider a secretariat document that outlines the progress and remaining challenges in implementing the Beijing Platform for Action in the Asia-Pacific region. The document is based on the outcomes of the national reviews undertaken in accordance with the "*Global Guidance Note*", as well as government

responses to the ESCAP regional survey of the 12 “Critical Areas of Concern” of the Beijing Platform for Action.

Delegations will be invited to deliver brief and concise statements on progress made and remaining challenges in achieving gender equality and women’s empowerment in the context of the Beijing Platform for Action. The outcome of the deliberations under this agenda item is expected to feed into the finalization of the outcome document for the Asian and Pacific Conference on Gender Equality and Women’s Empowerment: Beijing+20 Review. The deliberations will also identify critical issues relating to gender equality and women’s empowerment in the context of the development agenda beyond 2015.

Annotation

Under this agenda item, the Conference will review the draft Asian and Pacific ministerial declaration on advancing gender equality and women’s empowerment, which provides a forward-looking framework to accelerate the implementation of international and regional commitments in achieving gender equality and women’s empowerment in the Asian and Pacific region. The draft declaration would also serve as the regional input to the fifty-ninth session of the Commission on the Status of Women in 2015 on the 20-year review of implementation of the Beijing Platform for Action.

The initial version of the draft outcome document was reviewed by Governments at the third session of the Committee on Social Development, which was held in Bangkok from 18 to 20 August 2014. Comments and suggestions received at that meeting were incorporated, as appropriate, into the second version of the draft, which is presented for the consideration of the senior officials.

It is expected that, under this agenda item, the outcome of deliberations will be the endorsement of the draft Asian and Pacific declaration on gender equality and women’s empowerment, for submission to the ministers for adoption during the ministerial segment.

Annotation

Under this agenda item, the Conference will consider forward-looking policies to consolidate gains and accelerate implementation of international and regional commitments in achieving gender equality and women's empowerment in the Asia-Pacific region, including the Beijing Declaration and Platform for Action.

Ministers and heads of delegations will be invited to deliver their policy statements, which may highlight achievements, future challenges and policy responses in the implementation of the Beijing Platform for Action. The policy statements may also identify opportunities and areas for regional cooperation, including South-South cooperation, to advance the gender equality and women's empowerment agenda in the post-2015 era.

Representatives of United Nations organizations and intergovernmental organizations will be afforded the opportunity to make brief statements on measures and initiatives on gender equality and women's empowerment. A consolidated statement will be delivered by a representative of civil society, conveying the recommendations made by civil society organizations for the information of the Conference.

Any other matters raised by delegations and/or the secretariat will be considered under this agenda item.
