##### **Annotation**

The Meeting will review the progress made in the Asia-Pacific region in the implementation of the Madrid Plan of Action.

As a basis for its deliberations, the Meeting will have before it a note by the secretariat in which progress in implementing the Madrid Plan of Action is outlined and the gaps and challenges confronting the Asia-Pacific region with regard to population ageing are identified. The note is based on the findings of a regional survey on ageing that was sent to all members and associate members. Key areas for future action are also highlighted in the note.

Meeting participants may wish to share experiences and findings from the national review and appraisal process, including progress made in implementing the Madrid Plan of Action. The deliberations under this agenda item are expected to result in enhanced understanding of (a) the issues associated with the implementation of the Madrid Plan of Action and (b) good practices and lessons learned in the national review and appraisal process.

### **3. Consideration of key regional issues within the framework of the Madrid Plan of Action**

Government actions towards the implementation of the Madrid International Plan of Action on Ageing, 2002: achievements and remaining challenges (E/ESCAP/MIPAA/IGM.2/2)

#### **Annotation**

The Meeting will review key issues related to population ageing and regional priorities for future action under the three priority directions of the Madrid Plan of Action.

#### **(a) Older persons and development**

Issues covered will include the following: active participation in society and development; work and employment opportunities; rural development, migration and urbanization; access to knowledge, education and training; intergenerational solidarity; and income security, social protection and poverty prevention.

#### **(b) Advancing health and well-being into old age**

Issues covered will include the following: health promotion and well-being throughout life; universal and equal access to health-care services; older persons and HIV; training of care providers, health professionals and social service providers; mental health needs of older persons; and older persons and disabilities.

#### **(c) Ensuring enabling and supportive environments**

Issues covered will include the following: housing and the living environment; care for older persons and support for caregivers; neglect, abuse and violence; and images of ageing.

As a basis for its deliberations, the Meeting will have before it a note by the secretariat in which progress in implementing the Madrid Plan of Action is outlined and the gaps and challenges confronting the Asia-Pacific region with regard to population ageing are identified. The note is based on the findings of a regional survey on ageing that was sent to all members and associate members. Key areas for future action are also highlighted in the note.

The Meeting may wish to consider and identify key areas for regional cooperation. The deliberations under this agenda item are expected to result in a set of key priority issues for the next implementation cycle of the Madrid Plan of Action.

As a basis for its deliberations, the Meeting will have before it a draft outcome document, highlighted in which are the recommendations regarding regional priorities that were made at its preparatory meeting, held in Bangkok on 14 and 15 June 2017.

The Meeting may wish to consider the key issues under each priority direction of the Madrid Plan of Action for the next implementation cycle in the Asia-Pacific region, including a regional modality for further strengthening the implementation of the Madrid Plan of Action. The Meeting may also wish to adopt the outcome document.
