The Order of the Cabinet of Ministers of the Republic of Uzbekistan dated February 15, 2016 No. 111-F was adopted;

The composition of the permanent working group and 6 thematic working groups was approved;

What has been done in regards to the SDGs

Resolution of the Cabinet of Ministers of the Republic of Uzbekistan "On measures to implement the National goals and targets in the field of sustainable development for the period up to 2030";

Establishment of a Coordination Council

The main tasks of the Coordination Council:

- organization of effective work of the responsible ministries and departments for the implementation of the National goals and targets, ensuring intersectoral coordination and an integrated approach to achieving the SDGs;
- ensuring the inclusion of national goals and targets in the development of sectoral, regional and targeted development programs, strategies and concepts;
- hearing of reports of ministries, departments and working groups on the implementation and achievement of the results of the National goals and targets.


Establishment of an inter-agency working group and monitoring of the indicators of the National SDGs

The action plan includes the following tasks:

identification and integration of national strategy indicators with global SDG indicators;

identification of further actions for adaptation to the SDGs; conducting additional analysis and data collection;

consultations with the participation of international organizations, donors;




- In Uzbekistan, at the national level, only 125 targets out of 169 global targets were accepted. 44 targets were excluded, since they are not relevant for Uzbekistan. 4 targets were changed and nationalized.
- For example:
- Target 3.d. Ensuring the implementation of the International Health Regulations (IHR a basic WHO document, a modern version of the rules was adopted on 25.05.2005 at the 58th World Health Assembly) and preparedness for the implementation of measures in public health emergencies;
- Target 4. b. By 2020, significantly increase the coverage of higher education, the number of loans and grants, including international, for studying in universities;
- Target 5.a. Expand programs to support women in the realization of their rights and interests in the socio-economic sphere;
- Target 17.4. Maintain the level of public debt at a level that ensures the stability of the financial and economic state of the country.

Approval of national goals and areas of sustainable development until 2030, taking into account national specifics and priorities arising from the "Development Strategy of the Republic of Uzbekistan in

5 main areas for 2017-2020"

Improving the methodology of the indicators being developed and bringing them into line with international standards

National SDGs

Development of a system of indicators to monitor the implementation of the National SDGs on the basis of the adopted UN international indicators and the inclusion of statistical work on the collection of statistical data on the SDGs

Mechanisms to control the

execution of the resulting objectives in the implementation of national sustainable development goals in the Republic of Uzbekistan

Way forward

- Develop mechanisms and procedures for providing data on SDG indicators;
- Cooperate with international organizations on the development of methodologies and tools for collecting statistical data necessary for SDG indicators, and consistently introduce them into the state statistics system;
- Create and maintain an online database of indicators for national sustainable development goals.
